The above-mentioned regatta has applied for and received provisional USRowing Registered Regatta Status. By complying with the requirements of the application (summarized below), this regatta will be included under the USRowing group liability. Copies of this agreement will be sent to the Regional Judge-Referee representative, the Regional Technical Coordinator, and the Regional Directors.

Registered Regatta Requirements

- First aid facilities and medically trained personnel must be available at a clearly marked location during all
  practice and racing hours. A vehicle for emergency transportation must be readily available and manned at all
  times.
- All safety guidelines as shown on the Safety Checklist must be fulfilled to ensure coverage under the general group liability policy.
- Safety Checklist must be completed and signed by the Chief Referee and returned to USRowing by the Chief Referee within five days after the regatta.
- A traffic pattern must be posted and enforced during the regatta and all practice periods.
- The Chief Referee of your regatta must be a fully licensed USRowing Judge-Referee.
- All competitors must be individual USRowing members and USRowing membership must be made available at regatta registration.
- All regatta advertisements directed toward competitors must state that "All competitors must be individual USRowing members," and must list USRowing's address.
- USRowing membership must be verified and enforced by the regatta committee. Memberships collected at the regatta must be sent to USRowing Headquarters within five days after your regatta.
- All participants must file competitor listing forms with regatta entry forms. All competitor listing forms
  must be sent to USRowing for verification within five days after your regatta.
- Membership and safety guidelines as outlined in the regatta application MUST BE MET TO FULFILL INSURANCE REQUIREMENTS FOR A REGISTERED REGATTA.
- Send USRowing a tentative schedule, including the number of races and the intervals in between.
- Send USRowing a map of the course showing traffic patterns, hazards, and the location of any planned marshal boats.
- Notify USRowing of any variations on the Rules of Rowing that are requested. (See the Rules of Rowing 1-104[b].)

## USRowing General Liability Policy

- Policy Limit: \$1,000,000
- This is a Comprehensive General Liability Policy. It does not cover immediate medical payments to athletes
  or claims arising from operation or use of automobiles.
